



Napoleon Review & Win Contest - Official Rules

1. Description of Review & Win Contest

Customers can enter the 'Review & Win Contest' for a chance to win a Napoleon **Phantom Prestige® 500 RSIB** grill. They enter the contest by filling out the form on the contest entry page and validating their entry by leaving a review on Napoleon.com. The winner will be selected the week of August 15, 2023. Customers are only eligible to enter the draw once. *Note: For a review to be validated the entrant must use the same email they left the review with to enter the contest.*

A) How Review & Win Submissions Work

In order for customers to enter the 'Review & Win Contest', they will be required to complete the following steps:

- **Step 1:** The customer will navigate to the contest entry page
- **Step 2:** The customer will then submit their contact details and answer a skill testing question via the form on the contest page
- **Step 3:** The customer needs to leave a review on Napoleon.com to validate their entry.
